Prime Media Group Limited (ASX: PRT) - Corporations Form 604

On behalf of Mr Bruce Gordon, Birketu Pty Ltd, WIN Corporation Pty Ltd and their controlled entities (WIN Group), attached is a notice of change of interests of substantial holder (Form 604) in relation to Prime Media Group Limited (ASX: PRT).

The Form 604 discloses the WIN Group's voting power of 14.37%.

As set out in the 15 April 2021 SSN, in addition to the relevant interest held by the WIN Group in 23,577,135 PRT shares, at the time of the 15 April 2021 SSN the WIN Group had an economic interest in 29,050,000 PRT shares via cash settled equity swap transactions.

On 20 April 2021 Birketu unwound the swaps and converted to fully paid ordinary shares at \$0.23 per share.

We confirm that, as a result of the above transactions WIN Group's voting power in PRT increased from 6.44% to 14.37%; and the economic interest of the WIN Group in PRT remains at 14.37%.

#### Current economic interests via derivatives

As disclosed in the ASX announcement dated 25 November 2019, Birketu Pty Ltd previously had an economic interest in 29,050,000 Ordinary Fully Paid Shares by virtue of a cash-settled share swap transaction pursuant to agreement between Birketu Pty Ltd and Macquarie Bank Limited. This interest was disclosed on a voluntary basis as it did not constitute the acquisition of a relevant interest under section 608(8) of the Act irrespective of the operation of sections 609(6) and 609(7) of the Act. WIN and Bruce Gordon also held an economic interest in those shares by virtue of the entry by Birketu Pty Ltd into the cash settled share swap.

This share swap was unwound on 16 April 2021. Pursuant to the original terms of the share swap arrangement, Macquarie Bank Limited was required to pay Birketu Pty Ltd a cash amount upon the unwinding of the share swap, equal to the market price of PRT shares at that time (which was \$0.23 per share), less agreed fees. In the alternative to this cash payment, Macquarie Bank Limited and Birketu Pty Ltd agreed that M would satisfy its contractual obligation by transferred the PRT shares it held as a hedge for the cash settled share swap

arrangement to Birketu Pty Ltd. Those were then transferred to Birketu Pty Ltd on 20 April 2020, and Birketu Pty Ltd and Bruce Gordon accordingly acquired a relevant interest in those shares (as disclosed in this Form 604). As a result of the unwinding of the share swap, neither Birketu Pty Ltd. WIN or Bruce Gordon has any economic interests in PRT shares via derivatives.

Note that the previous Form 604 lodged on 15 April 2021 incorrectly referred to a previous cash-settled share swap transaction between Birketu Pty Ltd and Deutsche Bank AG with respect to 29,050,000 Ordinary Fully Paid Shares which was unwound on 21 November 2019 (as disclosed in the announcement dated 25 November 2019), rather than the cash-settled share swap transaction between Birketu Pty Ltd and Macquarie Bank Limited.
