## 1. Chairman's letter

Dear Shareholder,

On behalf of the Directors, I am pleased to invite you, as a valued Shareholder of AstiVita Limited (**AIR** or the **Company**), to participate in AIR's recently announced 1 for 3 non-renounceable entitlement offer of new AIR ordinary shares (**New Shares**) at an issue price of \$0.72 per New Share to raise approximately \$4,564,648 (before costs) (**Entitlement Offer**).

The Entitlement Offer will not be underwritten and there will be no shortfall facility which would otherwise enable Eligible Shareholders who take up their full Entitlement to apply for additional New Shares from a pool of those Entitlements not taken up by other Shareholders of the Company.

The issue price of \$0.72 per New Share represents a 3% discount to the 30-day volume-weighted average Share price (being \$0.744 as at 31 March 2021). Allotment of the New Shares issued under the Entitlement Offer will occur on 10 June 2021.

### Reasons for the Capital Raising

The funds raised by the Company will be invested during 2021 in the following ways:

- a) Investment of approximately \$500,000 into packaging and finished goods equipment to increase capacity to in excess of 20 million tubes (100ml tubes) per year.
- b) Investment of approximately \$250,000 into new product development. AIR has identified more than 120 products that it is intending to launch to the market over the next 12-18 months. The capital raising will expedite this process and will facilitate the funding of pilot scale manufacturing batches to supply samples of AIR products to customers and the retail market as well as obtain the necessary regulatory approvals. AIR will use its own equipment to package the pilot scale batches.
- c) Investment of approximately \$200,000 in website development and marketing to create market awareness and promote products to the key retail partners in US, EU and Australia. This will also include investment with Amazon fulfilment and logistics.
- d) Repayment of loans to Rainrose Pty Ltd (a related entity of Mr Lev Mizikovsky). Depending on the amount of funds raised, AIR will repay approximately \$2.5 million - \$3.5 million of the total loan outstanding of \$3.894 million. The repayment of these borrowings will improve the net equity position of AIR and enable AIR to consider alternative funding sources in the future.

In the event circumstances change or other opportunities arise, the Directors reserve the right to vary the use of the proceeds from the issue of the New Shares to ensure Shareholder benefits are maximised at all times.

## **2. Entitlement Offer Details**

---

### **2.1 The Entitlement Offer**

The Entitlement Offer is an offer to Eligible Shareholders of an estimated 6,339,786 New Shares at an Issue Price of \$0.72 per New Share, on the basis of 1 New Share for every 3 Share held (**Entitlement**), to raise approximately \$4,564,648 (before costs).

The Company intends to invest approximately \$1 million in packaging and finished goods equipment, product development and marketing. AIR will also repay between \$2.5 million and \$3.5 million of borrowings from Rainrose Pty Ltd, a related entity of Mr Lev Mizikovsky. The balance of funds will be used for working capital.

On the same date as announcing the Entitlement Offer, the Company applied to the ASX for the New Shares to be granted official quotation on the ASX. Official quotation of the New Shares is expected to occur on or about 10 June 2021.

The issue price of \$0.72 per New Share represents a 3% discount to the 30-day volume-weighted average Share price (being \$0.744) as at 31 March 2021.

The Entitlement Offer is non-renounceable. Accordingly, Entitlements do not trade on the ASX, and they cannot be transferred or otherwise disposed of.

An Entitlement and Acceptance Form setting out your Entitlement accompanies this Offer Booklet. Eligible Shareholders may subscribe for all or part of their Entitlement. There is no minimum subscription amount.

### **2.2 Eligibility of Shareholders**

### 3.2 Capital structure

### 3.3 Potential effects of the Entitlement Offer on Control of AIR

The Entitlement Offer is a pro-rata offer so that if all Eligible Shareholders take up their Entitlements and none of the Option Holders exercise their Existing Options and participate in the Entitlement Offer, the existing Voting Power of all Eligible Shareholders will remain the same.

However, if some Shareholders take up their Entitlements, Shareholders who do not take up all of their Entitlements will have their interest in AIR diluted.

The Company seeks to make the Entitlement Offer to all Shareholders and has extended the Entitlement Offer to Shareholders with registered addresses in the Prescribed Jurisdictions. Accordingly, if all other Shareholders take up their Entitlement, foreign Shareholders with registered addresses in the Prescribed Jurisdiction (at the date of this Offer Booklet) will not be diluted as a consequence of the Entitlement Offer, unless they elect not to take up their Entitlements.

### 3.4 Related Party

As a Director, Mr Lev Mizikovsky is also a substantial shareholder of AIR. His intention is to participate for his 100% entitlement under the Capital Raising. The effect of a change in ownership is reflected in Section 3.4 and 3.5 of this Offer Booklet.
