#### **ISSUE OF SECURITIES**

Following the general meeting ("EGM") of BetMakers Technology Group Limited (ASX:BET) ("BetMakers" or the "Company") held on 26 April 2021 and further to the Company's announcement dated 17 February 2021, BetMakers wishes to advise that today it has issued:

- 35,714,285 fully paid ordinary shares in the Company ("Placement Shares"), to raise A\$25 million (before costs) at A\$0.70 per Placement Share, to Matt Tripp;
- 32,000,000 unlisted options exercisable into fully paid ordinary shares in the Company ("Shares") subject to certain performance-based vesting criteria ("Options") to Matt Tripp. The Options have an exercise price of A\$0.70 per Option and expire 1 February 2024;
- 67,000,000 unlisted performance rights convertible into Shares subject to certain performance-based vesting criteria ("Performance Rights") to Matt Tripp; and
- 25,000,000 unlisted director performance rights convertible into Shares subject to certain performance and time-based vesting criteria under the Company's long term incentive plan ("LTIP") ("Director Performance Rights") to BetMakers' CEO Todd Buckingham.

All the above securities received shareholder approval at the last EGM. Please refer to the notice of EGM dated 25 March 2021 for the full terms of the securities.

Appendices 2A and 3G in respect of the above securities, along with the Appendix 3Y in respect of the change to the interest of Todd Buckingham, are enclosed.

#### **Cleansing Statement for Placement Shares**

In respect of the issue of the Placement Shares, the Company hereby notifies ASX under section 708A(5)(e) of the Corporations Act 2001 (Cth) ("Act") that:

- (a) today, 29 April 2021 the Company completed the issue and allotment of 35,714,285 Placement Shares;
- (b) the Company issued the Placement Shares without disclosure under Part 6D.2 of the Act;
- (c) the Company provides this notice under section 708A(5)(e) of the Act;
- (d) as at the date of this notice:
  - (i) the Company has complied with the provisions of Chapter 2M and section 674 of the Act as they apply to the Company; and
  - (ii) other than as set out in this announcement, there is no information that has been excluded from a continuous disclosure notice in accordance with the ASX Listing Rules and that investors and their professional advisors would reasonably require for the purpose of making an informed assessment of:
    - (A) the assets and liabilities, financial position and performance, profits and losses and prospects of the Company; or
    - (B) the rights and liabilities attaching to the Placement Shares.



#### Issue of Shares on exercise of Options under the LTIP

Additionally, the Company has issued 947,643 Shares as a result of the exercise of 1,000,000 Options pursuant to the cashless exercise facility under the LTIP.

The Company advises that it is not required to issue a cleansing statement under section 708A(5)(e) of the Act on the basis that the Options were issued under the LTIP in accordance with the relief provided under ASIC Class Order [CO14/1000].
