Answer: Yes, given the Company is an exploration company and not generating any revenue (other than interest income) it is expected that it will continue to have negative operating cash flows for the time being.

Answer: On 12 April 2021, the Company announced a heavily oversubscribed placement at \$0.018 raising \$3 million (before costs). A Share Purchase Plan for up to \$500,000 has also been offered to existing shareholders on the same terms. The Board and management have also exercised \$110,000 in options on 8 April 2021. The Company is now fully funded to deliver ongoing drill results through the rest of 2021.
