The NTA figures shown above are before and after the provision for deferred tax on the unrealised gains in the Company's investment portfolio. The NTA per share increased at the end of April, due to an increase in the value of almost all investments (on the respective Stock Exchanges), despite the strengthening of the Australian Dollar against USD and GBP.
