RED FOX GIPSY CREEK PROJECT DRILLING UPDATE

Chase Mining Corporation Limited (ASX: CML, "Chase Mining" or "Company") provides the following update on Red Fox Resources Pty Limited ("Red Fox"), in which Chase Mining holds 40%.

CML have been informed by Doug Young Chairman of Red Fox that drilling has been completed at its Gipsy Creek Project (EPM 26872), 18km northeast of the Ernest Henry mine, Cloncurry district, in northwest Queensland.

Commencing in late April, Red Fox carried out a three-hole diamond drilling programme on its Gipsy Creek project that was funded by a Queensland Government CEI grant (CML ASX Announcement 26 April 2021).

The Company also drilled one additional self-funded hole in the programme to test a separate geophysical (chargeability) anomaly known as "Romany" lying 1km west of the Gipsy Creek (Cloncurry Lineament) structure.

Logging of the holes and core cutting is in progress. Half core samples are being selected and sent to the laboratory in Mt Isa for analyses. Results of the drilling and analyses will be released to the market in due course.

Drilling Completed at Red Fox's Gipsy Creek Project

Red Fox Resources Pty Ltd (Red Fox) wishes to report that drilling has been completed at its Gipsy Creek Project (EPM 26872), 18km northeast of the Ernest Henry mine, Cloncurry district, in northwest Queensland.
