Brambles Limited: Appendix 2A

Please find attached an Appendix 2A relating to 1,777 ordinary shares in Brambles Limited which have been issued as a consequence of the exercise of share awards under the Brambles Limited MyShare Plan to former employees classified as “good leavers” under that plan. (Please note that 9,223 unlisted matched share rights granted under the Brambles Limited MyShare Plan have lapsed since the lodgement by Brambles of the Appendix 2A on 10 May 2021.)

The number of securities referred to in item 5.1 of the attached application takes into account the 4,492,471 fully paid ordinary shares in Brambles which have been cancelled as a result of the shares bought back from the 7 May 2021 to 25 May 2021¹.
