Please find attached an Appendix 2A relating to 350 ordinary shares in Brambles Limited which have been issued as a consequence of the exercise of share awards under the Brambles Limited Performance Share Plan. (Please note that 1,434 unlisted matched share rights granted under the Brambles Limited MyShare Plan have lapsed since the lodgement by Brambles of the Appendix 3G on 1st June 2021.)
