CLEANSING NOTICE UNDER SECTION 708A(5)(E) OF THE CORPORATIONS ACT 2001 (CTH)

NSX Limited ("NSXL" or "the Company") is pleased to announce that it has successfully concluded the first tranche placement of 17,507,151 shares at an issue price of 14 cents. This has raised \$2,286,001.04 after costs of the placement. The second tranche placement of 7,542,858 shares at 14 cents to raise \$1,056,000 is to be issued subject to shareholder approval.

These securities will rank equally with existing shares on issue.

In accordance with the requirements of Section 708A(6) of the Corporations Act 2001 (Cth) (**Corporations Act**), NSX gives ASX notice that:
