# COG Financial Services Limited – Extraordinary General Meeting Shareholders Update ("Update") - Change to Hybrid Meeting

**Sydney, 25 June 2021**: COG Financial Services Limited ("COG" or the "Company") advises that its Extraordinary General Meeting ("EGM") will be changed <u>from a physical meeting to a hybrid meeting</u>.

As previously advised to shareholders, the EGM is being held at 9.30am (AEST) on Wednesday, 30 June 2021 at Level 5, 126 Philip Street, Sydney, NSW 2000 and now will also be made available to Shareholders electronically through a virtual meeting.

## **COVID-19 MODIFICATIONS**

Given the significant health concerns attributed to the COVID-19 pandemic in Sydney, NSW, in addition to guidelines and restrictions issued by Australian state and federal governments, the Company considers that it is appropriate to also hold the EGM as a hybrid meeting, with virtual meeting accessible online. This is in a manner that is consistent with the temporary modifications to the Corporations Act 2001 (Cth) introduced by the Commonwealth Treasurer.

The Notice of the EGM ("Notice") was dispatched to shareholders on 28 May 2021 by post and electronically and can be viewed and downloaded online at the following link: https://www2.asx.com.au/markets/trade-our-cash-market/announcements.cog

Given the uncertainty surrounding the COVID-19 pandemic, by the time of the EGM, circumstances may have changed but this Update is given based on circumstances as at 25 June 2021. Accordingly, should circumstances change, the Company will make an announcement on the ASX market announcements platform and on the Company's website at <a href="https://cogfs.com.au/asx-announcements/">https://cogfs.com.au/asx-announcements/</a>

Shareholders are urged to monitor the ASX announcements platform and the Company's website.

All resolutions will be decided on a poll. The poll will be conducted based on votes submitted by proxy and at the Meeting by shareholders who have indicated that they intend to vote at the Meeting in accordance with the instructions set out below.

The Company strongly encourages shareholders to attend the meeting virtually, with strict protocols and number of attendee restrictions in place at the physical venue.



## **VENUE – PHYSICAL MEETING**

As previously advised to shareholders, the EGM is being held at 9.30am (AEST) on Wednesday, 30 June 2021 at Level 5, 126 Philip Street, Sydney, NSW 2000.

Further to the NSW Government restrictions:

- (1) The one person per 4 square metre rule will be applied.
  - Please note that to ensure appropriate social distancing physical attendance at the EGM will be limited to 12 persons including the Board of Directors. The Company therefore strongly encourages Shareholders to attend the meeting virtually to avoid the disappointment of not being able to attend in person.
- (2) Masks must be worn in entering the premises, during the meeting and on leaving the premises.

## Voting virtually on the day of the EGM
