GREENVALE STRENGTHENS BOARD WITH APPOINTMENT OF NEW NON-EXECUTIVE DIRECTOR

Highly experienced international mining and oil & gas executive Mrs. Dagmar Parsons joins the Greenvale team as it advances its Alpha Torbanite Project in Queensland to development
