As detailed in the attached notice, the Wilson Asset Management Group hold a relevant interest of 8.56% in Pengana International Equities Limited (ASX: PIA).

WAM Strategic Value Limited (**WAM Strategic Value** or **the Company**) was incorporated on 30 March 2021 and listed on the ASX today, Monday 28 June 2021. The Company is now included in the Wilson Asset Management Group.
