The share options (Options) entitle Ms Bernstein to one subscription right to acquire one ordinary share (Share) (or at the Company's discretion 1000 CDIs representing 1 Share). The exercise price at which 1 Share may be acquired on exercise of 1 Option is EUR 1820.28 (equivalent to EUR 1.82 per CDI or approximately AUD 2.84 per CDI based on the exchange rate at the Grant Date. The Options have been issued in two tranches with different vesting periods. The tranche 1 Options (36 Options) vest over a period of 44 months and the tranche 2 Options (170 Options) vest over a period of 47 months from the first day of the month in which the Grant Date falls. There is a waiting period of 4 years commencing on the Grant Date following which the Options may initially be exercised. Details of the Exercise Window and the Expiry Date for the Options are set out in the SOP 3.
