Stephe is Chair of 1st Group Limited and non-executive director of ASX listed BluGlass Limited (ASX:BLG) and Interactive Pty Limited.

Stephe has extensive corporate finance, CEO, senior management and operational experience,—particularly in the Australian and US markets, building on earlier work for telcos in the UK, Australia and the Asia Pacific region. He previously held roles as diverse as Chief Operating Officer of an aggressive wireless broadband infrastructure company, Consulting Director of NM Rothschild & Sons, and COO of Nextgen Networks. Before Nextgen, Stephe was founder and Managing Director of XYZed, where he developed and managed Australia's first competitive broadband wholesaler.

He has Science and Law degrees from Macquarie University and a Master of Laws from the University of Sydney.
