#### Completion of Unmarketable Parcel Buy-Back Facility

On 17 May 2021, LionHub Group Limited (ASX:LHB) (**LionHub**) announced details of an off-market share buy-back facility (**Buy-Back Facility**) to buyback all the shares held by shareholders who held unmarketable parcels of shares in LionHub (**Eligible Shareholders**) as at 7:00pm (Sydney time) on Friday, 14 May 2021 (**Record Date**).

In accordance with the terms of the Buy-Back Facility, Eligible Shareholders had until 5:00pm (Sydney time) on Wednesday, 30 June 2021 (**Closing Date**) to opt-out of the Buy-Back Facility or merge multiple holdings to form a marketable parcel (if applicable). Eligible Shareholders that did not exercise either of these options by the Closing Date had their LionHub shares bought back by LionHub at \$0.0035 per share (**Buy-Back Price**).

A total of 8,748,098 LionHub shares have been acquired under the Buy-Back Facility at the Buy-Back Price and have been cancelled in accordance with the Corporations Act 2001 (Cth). As a result, LionHub now has 817,601,632 ORD shares on issue. In accordance with the requirements of ASX Listing Rule 3.8A, **enclosed** is a copy of the Form 484 (Change to company details) lodged with ASIC and an Appendix 3H (Notice of cessation of securities).

Eligible Shareholders whose shares were bought back under the Buy-Back Facility will have their proceeds remitted to the bank account registered with LionHub and will be sent documentation advising them of the number of shares sold and the amount of proceeds remitted as soon as practicable.
