Corporate Governance Statement

Pacific Smiles Group Limited ("Pacific Smiles" or the "Company") and the Board of Directors ("Board") are committed to achieving and demonstrating the highest standards of corporate governance appropriate for the business. The Nomination and Remuneration Committee is also responsible for administering short term and long term incentive plans (including any equity plans) and reviewing Pacific Smiles' claw back policy in respect of performance-based remuneration. In addition, the Committee is responsible for reviewing and making recommendations in relation to the composition and performance of the Board and its Committees and ensuring that adequate succession plans are in place (including for the recruitment and appointment of Directors and senior management). Independent advice will be sought where appropriate.

The Committee is comprised of Ben Gisz (Chair, Non-Executive Director), Zita Peach (Independent, Non-Executive Director) and Hilton Brett (Non-Executive Director). Ben Gisz is a Non-Executive Director but is not considered independent according to ASX guidelines. However, the Board considers that Ben exercises his duties sufficiently independently from management and has the appropriate skills and experience to Chair this Committee effectively.

The number of meetings of the Committee and attendances by individual members during the Reporting Period is disclosed in the Directors' Report in Pacific Smiles' Annual Report.
