In accordance with ASX Listing Rule 3.13.2, Magellan is pleased to announce that all resolutions relating to the proposed transition of the Trust from a closed-ended listed investment trust on the official list of the ASX to an open-ended Active ETF quoted on the ASX under the AQUA Rules ("Transition"), as set out in the Notice of Meeting dated 30 July 2021, were passed by the requisite majorities at today's meeting.
