## Oropesa Tin Project – Drilling Progress Report

Elementos Limited (ASX:ELT) has reported another significant and shallow mineralisation intersection at its wholly owned, flagship Oropesa Tin Project in Spain with assays from single hole Expn\_061A returning the following results:

Expn\_061A      82.7m @ 0.27% Sn from 11.3m  
                    Includes: 18.0m @ 0.39% Sn from 11.3m, and  
                                    37.5m @ 0.30% Sn from 56.5m

*A full list of drill core assay results is shown in Table 2 on pages 5 & 6.*

These results follow assay data from 34 drill holes previously reported from this program. Assays from seven drill holes remain outstanding.

Elementos Chief Executive Mr Joe David said the drill hole assay results are material to the project due to the 1) shallowness, 2) significant mineralisation, 3) location outside the previously released 2018 Mineral Resource Estimate, and 4) the possibility it now links other previously defined zones of mineralisation.

“Drill hole Expn\_061A is located 58m along strike to the northwest of the mineralisation in drill hole Expn\_055A announced last week<sup>1</sup>. This assay data adds further significance to the existence and continuity of a new shallow tin mineralisation zone, near surface, and towards the centre of the previously reported Mineral Resource at Oropesa,” Mr David said.

“These results continue to validate the geological interpretation and understanding that the Elementos project team has of the Oropesa Tin deposit and we look forward to the receipt of the remaining seven drill holes, located along strike or down dip, to confirm the full extent and grades of this mineralisation zone,” he said.

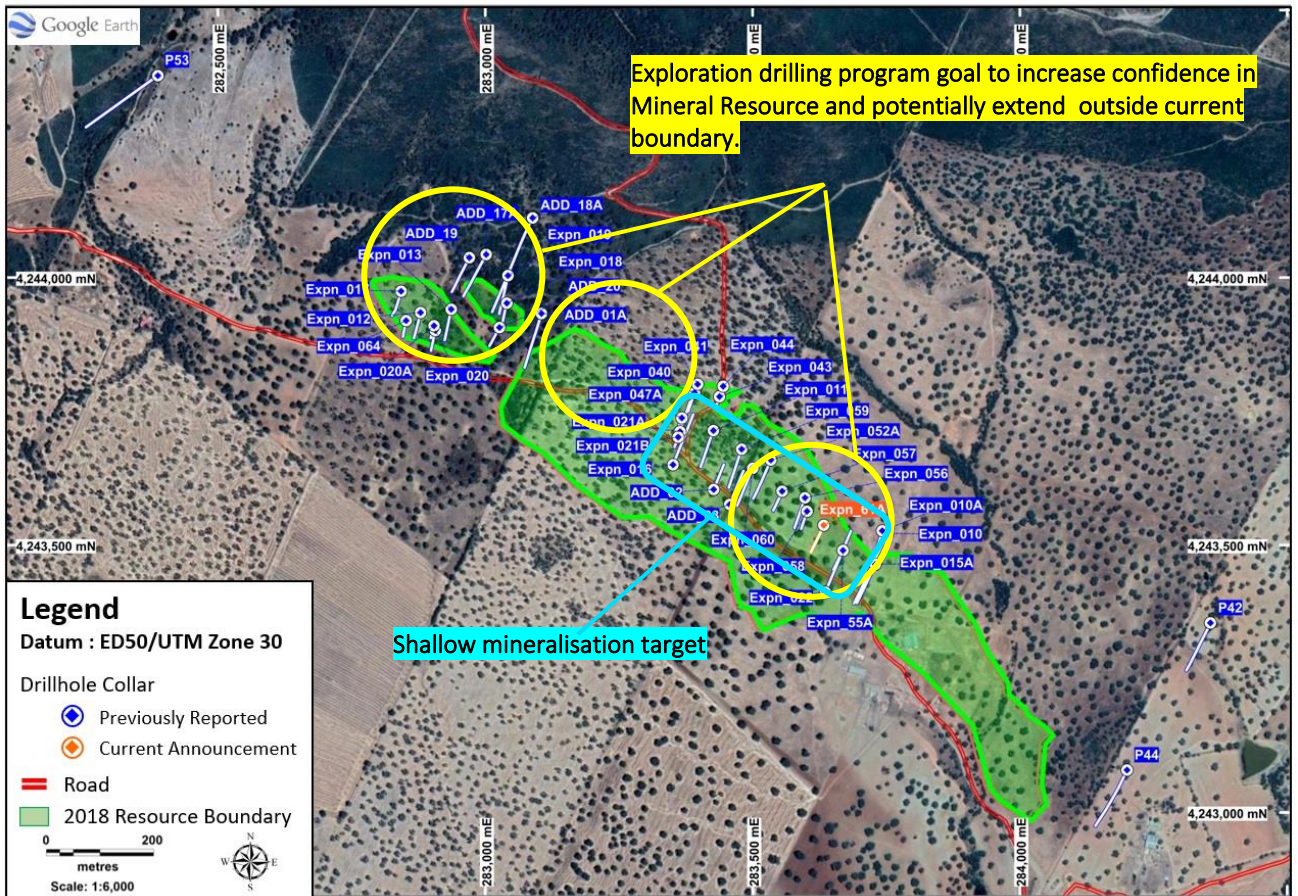


Figure 1. Location of drill holes with reported assay data as at 30 August 2021, from the exploration drilling program at the Oropesa Tin Project, Spain

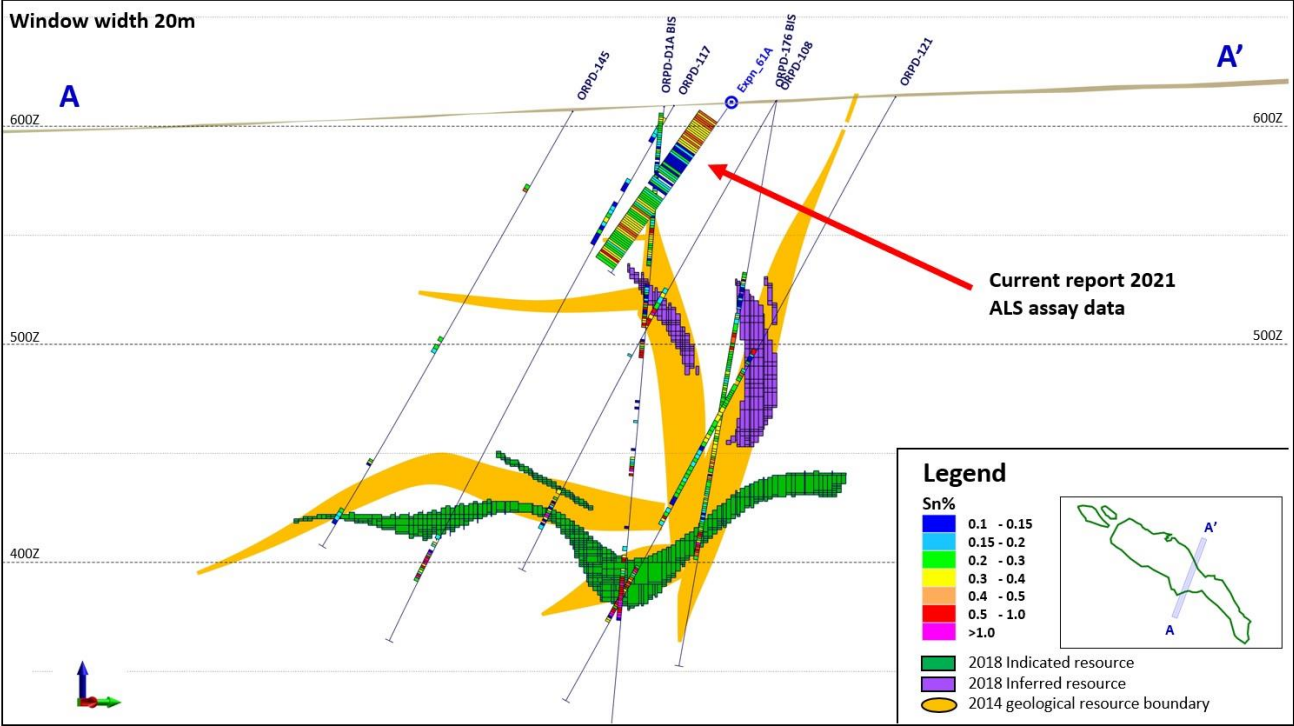


Figure 2. Oropesa 2021 resource infill diamond drilling, Expn\_061A

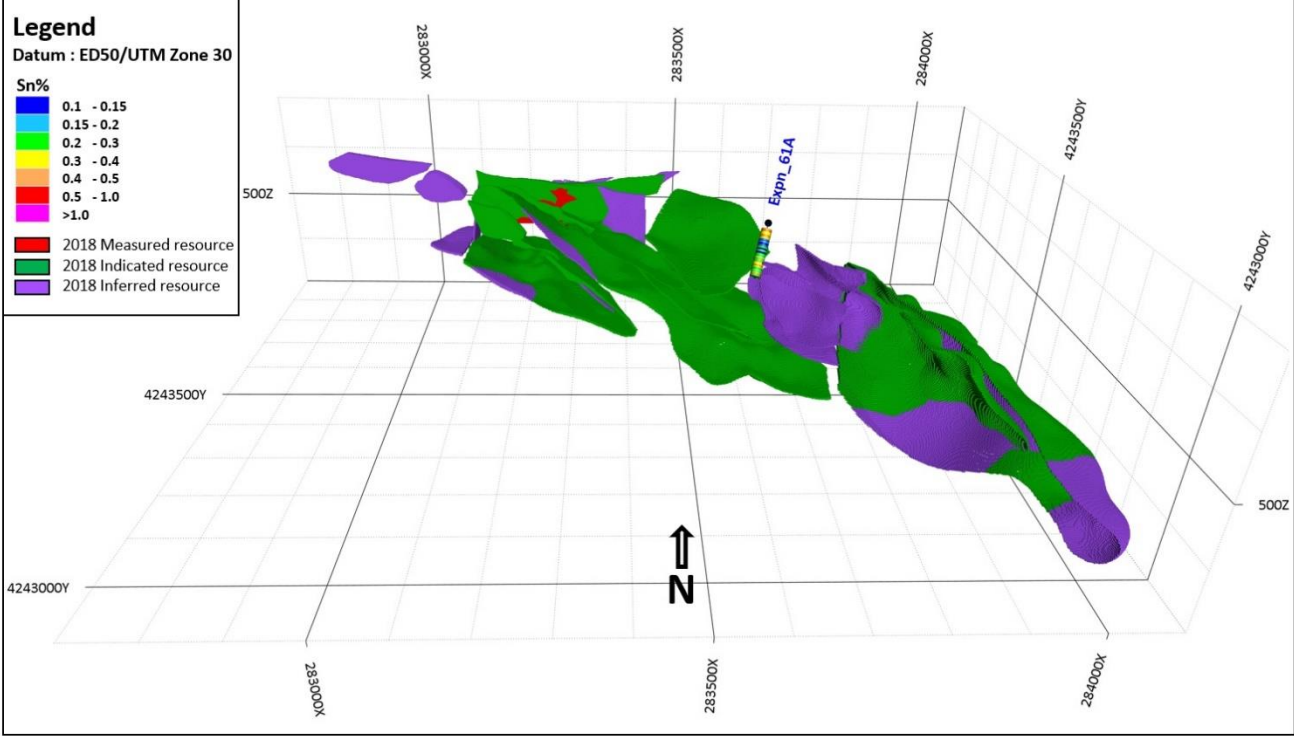


Figure 3. Oropesa 3D image of 2018 geological resource depicting the location of Expn\_061A



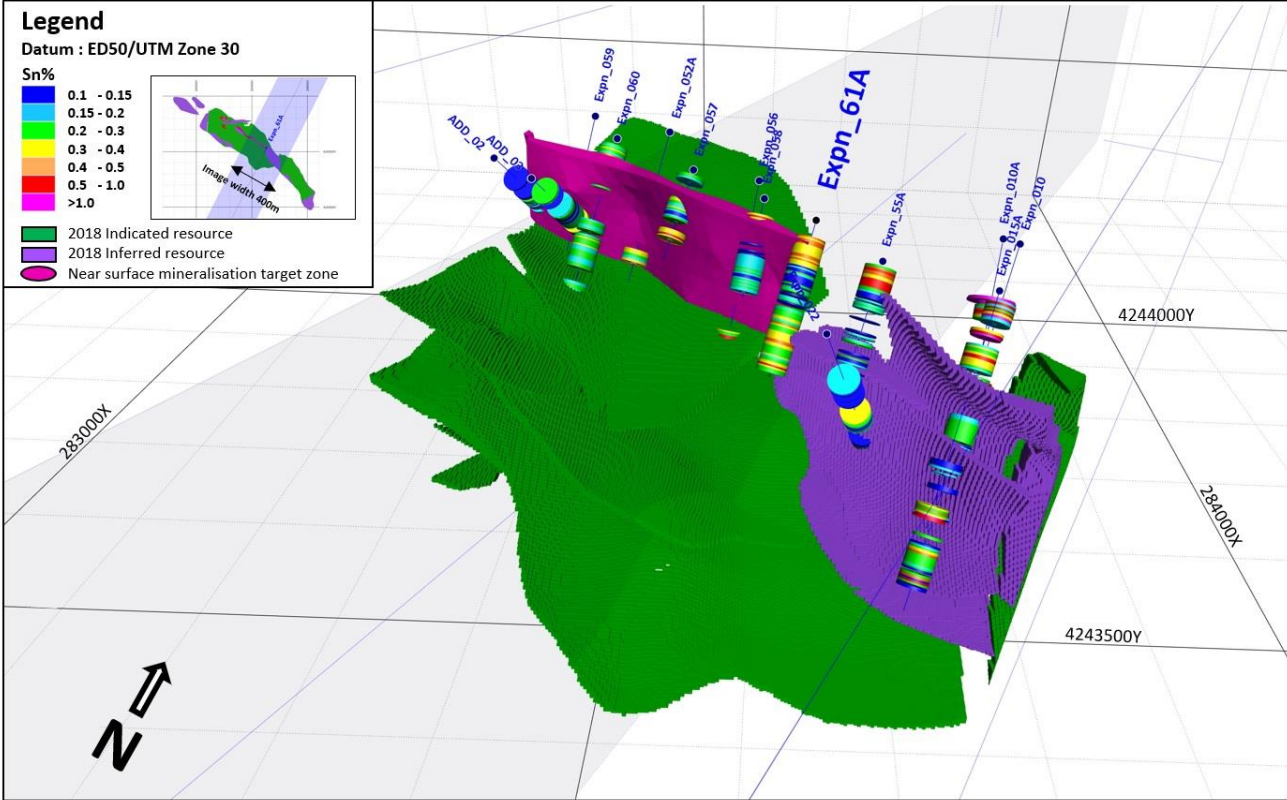


Figure 4. Detailed 3D image of Expn\_061A and additional shallow drill holes completed during the diamond drilling program depicting confirmation and continuity of the shallow mineralisation target.
