

# **Drilling program to commence at Koppamurra**

## **Highlights**

- Planning and preparation completed for 8,000m air-core drilling program
  - Program developed to confirm regional prospectivity of flagship Koppamurra project
  - Primary objective to confirm regional nature of mineralisation across granted (SA) tenure
  - Additionally, program will aim to identify thick, high-grade mineralisation to support estimation of an Indicated Mineral Resource
  - Highly-credentialled Exploration Manager and field crew engaged to manage and execute drill program
  - Experienced, South Australian based, drilling contractor engaged
- Drilling expected to commence at the beginning of October and will be ongoing until end of year
- Exploration PEPR's (Programs for Environmental Protection and Rehabilitation) approved
- Naracoorte, SA, regional office and warehouse established

Australian Rare Earths Limited (ASX: AR3) ('AR3' or the Company) is pleased to provide an exploration and community update on the flagship Koppamurra Project ('Koppamurra'), located across 3 granted tenements, South Australian EL's 6509 and 6613 and Victorian EL 7254.

Following the successful 79-hole drill program completed in June, which delivered excellent, high-grade results from areas adjacent to and extensional from the existing Red Tail and Yellow Tail resources, AR3 continues to focus on rapid exploration of Koppamurra and has completed planning for an upcoming 8,000m air-core drill program, which is set to commence in early October.

To date, AR3 has drilled less than 2% of Koppamurra, which resulted in a JORC 2012 Inferred Mineral Resource of 39.9Mt @ 725ppm TREO¹ at the Red Tail and Yellow Tail deposits. Importantly, exploration at Koppamurra only requires shallow drilling and can be rapidly advanced at relatively low-cost. AR3 is well-funded to advance exploration programs over the next 12 months and has a number of targets identified across its large landholding at Koppamurra.




Figure 1: Koppamurra Drilling Location Map

The upcoming 8,000m drill program will focus on confirming the regional prospectivity of Koppamurra, with drilling planned in three main areas centered around the localities of Comaum, Hynam and Frances (see **Figure 1**). An additional objective of the program is to identify thick, high-grade mineralisation to support the estimation of indicated mineral resources within areas where AR3 has negotiated Landowner Access and Compensation Agreements.

South Australia mineral exploration licence holders have a statutory requirement to identify relevant environmental, social and economic impacts and obtain relevant approvals prior to undertaking exploration activities. Importantly, the Company's Programmes for Environmental Protection and Rehabilitation (PEPR's) have been approved.

Following receipt of access agreements with owners and managers of land which will be drilled, AR3 appointed an experienced drilling contractor to undertake the program, along with a well-credentialled Exploration Manager and field crew. Drilling is scheduled to commence in early October and will be ongoing until the end of the year.

The Company has a focused approach to partnering with the community to grow Koppamurra in a responsible and sustainable manner. Establishing a presence in Naracoorte is a major objective of AR3 and

this has been progressed with an Office and Warehouse established for the ongoing exploration programs and community engagement efforts.
