The Board of Directors of Gratifii Limited and its controlled entities ("Gratifii" and/or "the Company") are committed to achieving the best practice in corporate governance commensurate with the Company's size, its operations and the industry within which it operates.

The Company has adopted a Corporate Governance Plan which provides the written terms of reference for the Company's corporate governance practices.

This Corporate Governance Statement summarises the corporate governance practices adopted by the Board of Directors and the Company's compliance with the Corporate Governance Principles and Recommendations 4th Edition (Recommendations) during the reporting period ended 30 June 2021.

The Principles and Recommendations are not mandatory.
