Vectus Biosystems Limited (ASX:VBS or the Company) advises that it has issued a total of 215,109 fully paid ordinary shares as follows:

- A total of 200,000 fully paid ordinary shares to two note holders following the conversion of 200,000 convertible notes, being 100,000 notes held by each note holder, at a conversion price of \$0.50 per note. In relation to the accumulated interest on these notes, at an interest rate of 6% per annum, it was paid as a total of 9,276 shares calculated at \$1.37 per share, as provided for in the Convertible Note Deed.
- A total of 5,833 fully paid ordinary shares to three employees on the exercise of 5,833 options, for no consideration following vesting. These options were previously issued under the Company's Employee Incentive Plan (EIP).
