## MT CANNINDAH CONTINUES TO DELIVER WITH A HUGE 92m @ 1.2%Cu FROM THE BOTTOM SECTION OF HOLE 2

#### **HIGHLIGHTS**

- The lower half of 21CAEDD002 has added a further 92m @ 1.2%Cu (205m-297m) which along with the previously announced 117m @1.01% Cu (34m-151m) from the first portion of the hole, together with intervening intervals, combines to form a massive 282m @ 0.94% Cu, 0.3 g/t Au, 19 g/t Ag which translates to 282m @ 1.28% Copper Equivalent.
- Within the surface to 34m portion of hole 21CAEDD002, there is a partially mined-out, high
  grade supergene intercept, where unmined sections returned high grade Cu: for example 2m
  between 23m to 25m returned 6.24% Cu, 2m between 30m to 32m returned 3.42% Cu with
  significant Au, Ag.
- The next hole, (21CAEDD003) still has assay results pending with the hole ending at 762.6m. Cannindah is expecting these in the short term.
- it is worth noting that 21CAEDD003 encountered chalcocite rich supergene material from 15m to 33m then into primary chalcopyrite mineralisation and pyritic infill breccia. The hole is testing the deep plunge of the copper mineralised zone, nearly at a right angle to the direction drilled by hole 21CAEDD002
- New diamond drilling of other targets such as Cannindah East where CAE are also expecting encouraging results (refer figure 2 below) is yet to occur.




Fig 1. Mt Cannindah project Granted Mining Leases and EPMs, Central Queensland.

Cannindah Resources Limited ("Cannindah", "CAE") is pleased to announce the next set of assay results from the drilling program currently underway at Mt Cannindah, copper gold silver project south of Gladstone near Monto in central Queensland (Figs 1 to 3). This drilling program was planned such that it may extend the current JORC resource, as well as test the continuity of higher-grade copper zones within the project area, and possibly locate new areas of interest for follow up and potential in-fill drilling. CAE has made major revisions to the planned drilling after Intersecting copper mineralisation over hundreds (100s) of metres in the first 4 completed holes. (Figs 4).

The first hole (21CAEDD001) was abandoned after hitting old workings and mining voids at 6m.

The second hole (21CAEDD002) hit some old workings at the top of the hole and then drilled mostly copper mineralised and sulphidic breccia over 330m.

CAE previously reported assay results from the top 151m of the hole (see CAE ASX release 28th Sept 2021).

The top of the hole from surface to 34m encountered voids and old workings in places resulting in low core recovery. Coherent portions with higher recoveries returned some high grade copper, gold and silver indicative of the historic supergene grades at Mt Canindah. Results include:

- 7m @ 0.68g/t Au, 51 g/t Ag (0 -7m)
- 2m @ 8.24% Cu, 0.59 g/t Au, 65 g/t Ag (23m-25m)
- 4m @ 3.12% Cu, 1.08 g/t Au 49 g/t Ag (30m-34m)

CAE previously reported 117m @ 1.08% Cu, 0.38 g/t Au ,28 g/t Ag. (34m to 151m).

CAE has now received assay results from the remainder of hole 21CAEDD002 and is pleased to report high grade copper results over lengthy intervals ,consistent with the geological observations reported in CAE ASX release 28<sup>th</sup> Sept 2021. Two particular intervals are of note:

- 92m @ 1.2% Cu, 13.5 Ag, 0.3 g/t Au.(205m to 297m).
- Combining the above interval with the previously announced 117m @ 1.01% Cu (34m-151m) and adding in the intervening variably mineralised intrvals results in an expansive interval of:
- 282m @ 0.94% Cu , 0.3 g/t Au ,19 g/t Ag , at current prices translating to 282m @ 1.28%
   Copper Equivalent.

These intervals highlight the success of hole 21CAEDD002 in confirming the continuity of higher-grade copper zones within the project area, with the potential to increase the current JORC resource. It is also worth noting that the Cannindah Infill breccia mineralisation carries significant silver and gold in addition to copper. The controls on the higher grade Au and Ag zones are still to be delineated.

Fig 5 shows hole 21CAEDD002 in an oblique section in relation to historic holes. A significant point is that this hole confirms the continuity and extent of mineralisation in an oblique long section.running between fences of holes dilled on cross sections. Hole 21CAEDD002 significantly contributes to understanding the geometry , control and continuity of grade in the Cannindah Cu-Au-Ag Breccia deposit , essential to maximising the opportunity to expand upon the existing JORC resource.


The close relationship of observed chalcopyrite and Cu grade is shown in histogram form on the oblique long section in Fig 6. The table in the appendix lists the complete Cu,Au,Ag assays and pyrite, chalcopyrite visual estimates for whole of 21CAEDD002.

Figs 7 to 12 and core photos which illustrate the infill chalcopyrite rich breccia zones accompanied by their assayed copper grades, distributed for 169m to 297m.






Fig 2. Mt Cannindah project Location of identified resources & known targets








Fig 3. Mt Cannindah project geology and prospect areas




Fig 4. Mt Cannindah mine area, plan view of recent drillhole 21CAEDD002 & 3 traces in relation to previous drilling and copper results. Also shown are the mineralized envelopes at surface (400m RL) and 200m below surface. These envelopes are mainly defined by >0.3 % Cu, they contain the blocks within the current resource model.




Fig 5. Mt Cannindah cross section (20m window) showing trace of hole 21CAEDD002 with complete assay results. Also shown are historic copper intercepts and mineralized envelope containing the blocks within the current resource model.






Fig 6. Mt Cannindah cross section profile hole 21CAEDD002 with histogram of copper lab assay results for complete hole, plotted against visual estimates chalcopyrite content.




Fig 8. Primary copper mineralisation Hole 21CAEDD002 , 219,220m ,8%-10% visual estimate of chalcopyrite in the interval 219m-221m. Lab assay result 2.00%  $\,$ Cu




Fig 10. Primary copper mineralisation Hole 21CAEDD002, 288.5m, -5% visual estimate of chalcopyrite in the interval 288m-289m, Lab assay result 2.10% Cu.

The third hole 21CAEDD003 has encountered significant copper mineralisation, with a chalcocite rich supergene zone (15m-33m) present underneath a leached oxidised cap (0m-15m), before going into primary chalcopyrite mineralisation and pyritic breccia, cut by pre and post mineral dykes over a drilled interval of 33 to 762.6m. The tenor of the copper is variable but contains many tens of metres of 1% to 5% (or more) chalcopyrite. Copper assays are awaited, preliminary tests from visual estimates of chalcopyrite, and PXRF analyses of sludge samples to date, all indicate significant copper values should be returned over large sections of at least the first 500m or so of hole 21CAEDD003. Au and silver assays are also awaited. This hole was designed to test the plunge of the mineralisation to the west, it was drilled approximately west (260° magnetic), which is effectively 50 plus degrees different to the south-south-west (207° magnetic) bearing of hole 21CAEDD002 – see Fig 4.

Cannindah Resources Limited looks forward to receiving the assays for 21CAEDD003 in the short term and will update shareholders as to the outcome as soon as possible. In the interim the drilling program continues at Mt Cannindah whilst we await the results of other holes being completed. CAE currently has over 1000 samples at the laboratory in Townsville awaiting assay.



### Data aggregation methods

In reporting Exploration Results, weighting averaging techniques, maximum and/or minimum grade truncations (e.g. cutting of high grades) and cut-off grades are usually Material and should be stated.

No cut-offs have been routinely applied in reporting of the historical drill results or the drillhole 21CAEDD002 reported here.

The Cu-Au-Ag breccia style mineralisation at Mt Cannindah is developed over considerable downhole lengths. The breccia is generally mineralised, although copper grade and sulphide content is variable. In addition pre and post mineral dykes and intrusive bodies can mask the mineralisation .Down hole Cu-Au-Ag intercepts have been quoted both as a semi-continuous, aggregated down hole interval and also as tighter higher grade Cu-Au-Ag sections. In addition, historical results have been reported in the aggregated form displayed in the ASX Announcement for CAE, March, 2021, many times previously. There are some zones of high grade which can influence the longer intercepts, however the variance in copper and gold grade is generally of a low order...

The assumptions used for any reporting of metal equivalent values should be clearly stated.

A copper equivalent has been used to report the wider intercept that carries Au and Ag credits with copper being dominant. Only raw economic values have been used based on current metal prices. No formal metallurgical work is available for Mt Cannindah at this stage, so metal recoveries have not been used in the copper equivalent calculation. 30 day average prices in USD for October,2021, have been used for Cu, Au, Ag, specifically copper @ USD\$9250/tonne, gold @ USD\$1750/oz and silver @ USD\$23/oz.

## Relationship between mineralisation widths and intercept lengths

The relationships are particularly important in the reporting of Exploration Results. If the geometry of the mineralisation with respect to the drill hole angle is known, its nature should be reported

21CAEDD002 reported here is oriented along the strike of the 100m plus-wide infill breccia zone at Mt Cannindah. The hole was drilled to the south (203 mag azimuth), the Infill breccia is massive textured and clasts and matrix have a generally random, non-preferred orientation. Pre and post mineral dykes cut the drill hole, generally in two orientations, north south, semiparallel to the hole, and east west, right angles to the hole.
