## Prophecy Successfully Completes \$7.7M Equity Raising

### Highlights

- Firm commitments received for \$7.7 million equity raising, comprising a one-tranche placement of approximately 9.5 million shares at \$0.81 per share to new and existing sophisticated, professional and institutional investors
- Placement price represents a 1.7% premium to the 10-day Volume Weighted Average Price (VWAP)
- Funds raised will be primarily applied towards building on current sales momentum with the company's eMite and Snare products, boosting Prophecy's penetration of the large and fragmented global cybersecurity and cloud contact centre analytics markets

**Sydney— Wednesday, 20 October 2021**— Business software developer Prophecy International Holdings Ltd (ASX: PRO, "Prophecy" or "the Company") is pleased to announce that the Company has successfully completed a \$7.7 million equity raising via share placement. The raising will see approximately 9.5 million new shares issued at \$0.81, being a discount of 14.8% to the last traded price and a premium of 1.7% to the 10-day Volume Weighted Average Price (VWAP).

Funds raised will be primarily applied towards expanding the Company's business development team, with a key focus on building on current sales momentum with the company's eMite and Snare products.

The raising has been completed in a single tranche issuing fully paid ordinary shares to new and existing sophisticated, professional and institutional investors, using the Company's placement capacity pursuant to ASX Listing Rule 7.1. All new shares are expected to be allotted on Monday 25 October.

Curran & Co Pty Ltd acted as sole lead manager to the placement.
