QUARTERLY ACTIVITY REPORT & APPENDIX 4C: QUARTERLY COMMITMENTS REPORT

Yellow Brick Road Holdings Limited (**YBR** or the **Company**) attaches the Company's Quarterly Activity Report and Appendix 4C Report for the quarter ended 30 September 2021.

During the quarter ending 30 September 2021, the principal activity of the consolidated entity consisted of mortgage broking, aggregation and management services.

EXECUTIVE SUMMARY

Areas to highlight for the three months ended 30 September 2021 are as follows (with comparisons to last quarter):

- YBR's cash balances as at 30 September 2021 were \$9.2m, down \$3.3m on the \$12.5m at the end of
 the prior quarter. \$3.0m of the decrease reflected the purchase of Class C Notes in Resi Wholesale
 Funding's ("RWF") securitised lending program (YBR has a 50% stake in the RWF joint venture).
 Other material components included the repayment of \$450k of the CBA corporate debt facility, receipt
 of \$479k representing the final instalment from sale of Wealth and a \$0.1m deficit in net operating
 cashflows.
- YBR's net cash (gross cash less gross drawn debt) as at 30 September 2021 was \$6.3m (Q4 FY2021 \$9.2m) with \$11.2m available in total funding (Q4 FY2021 \$14.5m). This net cash is after excluding the \$3.0m Class C Notes purchase referred to above.
- The net cash flow from operating activities was a deficit of \$0.1m (Q4 FY2021 \$1.0m surplus). The
 small operating cashflow deficit resulted primarily from increased net receipts, relating to a strong
 quarter in home loan settlements but offset by timing differences between the receipt of commissions
 from lenders and corresponding payment to brokers.
- Operating Outflows (excluding branch and broker share of revenue) decreased by 18.1% to \$6.0m
 (Q4 FY2021 \$7.3m). The prior quarter included a payment of \$1.5m in annual insurance premiums.
- Underlying Loan Book size increased by 4.1% to \$53.8b (Q4 FY2021 \$51.7b).
- Residential and commercial loan settlements totalled \$5.4b in the September Quarter representing an increase of 34% on the prior quarter and 73% versus prior year.

FINANCIAL COMMENTARY

Summary

The reported net operating cash deficit for Q1 FY2022 was \$0.1m (Q4 FY2021: \$1m surplus).

As at 30 September 2021, the Company had \$9.2m in cash and cash equivalents and \$4.9m in borrowing facilities (\$2.9m drawn and \$2.0m undrawn).

Operating Cash Receipts

Receipts from customers increased to \$63.7m (Q4 FY2021: \$56.5m) reflecting the 34% increase in settlements from the prior quarter.

The surplus in receipts from customers, after branch and supplier pay away (Net Receipts) was \$5.9m (Q4 FY2021: \$8.3m).

Operating Cash Outflows

Operating cash outflows, excluding branch and broker share of revenue, decreased by \$1.3m (18.1%) to \$6.0m (Q4 FY2021: \$7.3m).
