

## **Jobkeeper Payments: s323DB(1) Notice**

Attached is the notice required by subsection 323DB(1) of the Corporations Act, being the jobkeeper payments disclosure required by that provision.

The jobkeeper payments referred to in the notice were received by Kegstar Pty Limited (Kegstar) whilst it was a Brambles subsidiary. Kegstar ceased to be a Brambles subsidiary during April 2021.

Whilst it was a Brambles subsidiary, Kegstar operated a standalone beer keg pooling business servicing the on-premises hospitality industry. Its operations and turnover were materially impacted by the Covid-19 restrictions from March 2020 to January 2021. During that period, Kegstar was entitled to jobkeeper payments under the jobkeeper scheme due to the impact of those restrictions on its actual and projected turnover. It therefore applied for and received the payments referred to in the attached notice.

Despite Kegstar no longer being a Brambles subsidiary, and notwithstanding it was entitled to jobkeeper payments, the Brambles Board determined that it should voluntarily repay the jobkeeper payments received by Kegstar.

The release of this announcement was authorised by the Brambles Board.
