COLLINS FOODS LIMITED - NOTICE REGARDING JOBKEEPER PAYMENTS

Thursday, 11 November 2021: Collins Foods Limited (ASX: CKF) provides notice relating to JobKeeper payments for the purposes of section 323DB of the *Corporations Act 2001 (Cth)*. The notice relates to Collins Foods Limited's financial year ended 2 May 2021 during which \$4.2 million was received for Sizzler Australia employees. Of this amount, \$2.4 million was a direct pass through to employees (top up to the minimum fortnightly wage of \$1,500), with the balance of \$1.8 million covering wages for hours worked by employees.

The balance of \$1.8 million was repaid in full.
