JobKeeper Payments Notification

The Australian Securities & Investments Commission (ASIC) has required that any listed entity disclose the amount of JobKeeper received, through the ASIC JobKeeper s323DB Notice provided following this letter.

The JobKeeper scheme was a subsidy offered to assist businesses impacted by COVID. LaserBond met the eligibility requirements for the period from April to September 2021.

LaserBond is considered support to essential services, with the majority of its customers requiring continued supply of its products and services. Power generation, mining and minerals processing, oil and gas, transport, agriculture and manufacturing all represent parts of the economy deemed essential and required LaserBond's continued operations.

Despite being considered essential services, LaserBond initially experienced a decline in revenue from our Services segment, related to the reclamation of wearing parts generally based around tightly scheduled maintenance or breakdowns. With businesses managing their own COVID risk, many LaserBond customers restricted access to their facilities causing delays to maintenance. This caused customers to keep their equipment running for longer and coping with the reduced efficiencies caused by growing wear on their components.

The receipt of JobKeeper allowed LaserBond to ensure that all employees remained employed full-time (protecting our operational skill and business development team) and supported the need for increased hygiene procedures, social distancing arrangements, split shifts, support for working from home arrangements, and the monitoring of, and communication with, all employees.
