APM Human Services International Limited ('APM' or 'the Company) is pleased to announce that it will list on the Australian Securities Exchange (ASX) today under the ticker code "APM".

The Company's listing on the ASX follows a highly successful initial public offer (IPO) process, through which APM raised approximately \$982.1 million via the issue of 276.7 million shares at an Offer price of A\$3.55 per Share under the prospectus lodged earlier this month.

Importantly the IPO, which was strongly supported by global and domestic institutional and retail investors, has allowed more than 4,000 APM team members to become shareholders through the employee gift offer and employee offer.

APM is a multi-national human services provider, enabling a better life for more than one million people in the last financial year across the 10 countries in which it operates, employing more than 7,000 people. For people with injury, illness or disability, as well as children and the elderly, the unemployed, and those facing hardship or harm, APM is making a positive and lasting social impact through the services it provides every day.
