Pre-quotation disclosure

The following information is provided to ASX Limited (**ASX**) for release to the market in connection with the admission to the official list and official quotation of all of the fully paid ordinary shares (**Shares**) in Tissue Repair Ltd (ASX:TRP) (**Company**) in connection with the Company's initial public offering (**Offer**) of Shares pursuant to a prospectus lodged with the Australian Securities and Investments Commission and ASX on 7 October 2021 (**Prospectus**).

The Company confirms that the Offer closed on 29 October 2021 and the issue of 19,130,440 ordinary shares to investors at an issue price of \$1.15 per Share has been completed, with the Company raising \$22,000,006 under the Offer. Allotment of the Shares available under the Offer completed on 16 November 2021.

In addition, on 15 November 2021 the Company issued:


- 8,152,123 fully paid ordinary shares to various convertible note holders under the Convertible Note Deed Poll dated 30 April 2021;
- 132,980 fully paid ordinary shares to the Company's directors, consultants and service providers;
- 6,035,580 unquoted options under the Company's long term incentive plan.

The Company applied for quotation of its Shares on, and admission to, the official list of ASX on 7 October 2021.
