Notice under Section 708A(5)(e) of the *Corporations Act 2001 (Cth)*

On 8 December 2021, Leigh Creek Energy Limited (the "Company") issued 15,619,048 fully paid ordinary shares in accordance with the terms of its Subscription Agreement with Energy Exploration Capital Partners, LLC, which was announced to the market on 5 January 2021.
