Notice under section 708A(5)(e) of the Corporations Act 2001 (Cth)

This notice is given by ReNu Energy Limited (**ReNu Energy**) (**ASX: RNE**) under section 708A(5)(e) of the *Corporations Act 2001* (Cth) (**Corporations Act**).
