

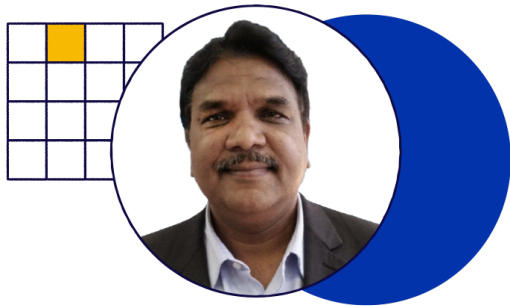

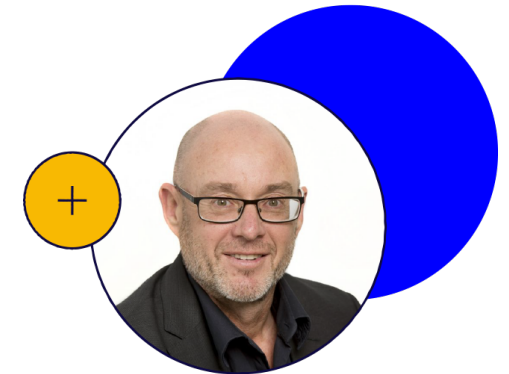

FY2021 Operational Highlights

- **Listed on the OTCQB (SNNSF)** venture market in the USA
- **Acquired Snap Network Surveillance**, a world leader in AI-powered multi-camera tracking software
- **Raised \$7.15m** in January 2021 to accelerate revenue growth and enhance our delivery capabilities to global customers
- **Established North American headquarters in Las Vegas** and grew the team from 2 to 10 people with a strong focus on sales and customer support.
- **Entered into an agreement to acquire Scancam** for an upfront consideration of \$6.5m.

FY2022 Outlook

- **Revenue guidance of >\$11.0m, up 111% YoY**
- **ARR run rate of > \$8.0m by end June 2022**
- **Customer net retention rate of 120%+**
- **Raised ~\$7m** in November and December 2021 via a placement and a SPP to fund continued growth momentum
- **Strong pipeline of opportunities** in all key verticals: smart cities, casinos, retail and smart surveillance
