Net Asset Value as at 17 December 2021

The weekly estimated unaudited net asset value (NAV) before withholding tax as at 17 December 2021 was \$0.72* per unit.

If estimated tax on unrealised portfolio gains or losses were recognised, the weekly estimated unaudited post tax net asset value as at 17 December 2021 would be \$0.63* per unit.

Calculation of weekly NAV

This weekly unaudited NAV estimate has been calculated by reference to the Fund's most recent estimated unaudited monthly NAV at 30 November 2021 (being \$0.71 per unit on a pre-tax basis and \$0.63 per unit on a post-tax basis which applied an AUD:USD foreign exchange rate of 0.7127), adjusting for changes in the AUD:USD foreign exchange rate.

The applicable AUD:USD foreign exchange rate applied in calculating the estimated unaudited NAV as at 17 December 2021 was 0.7125.

These weekly estimates do not take into account all intra-monthly accruals, which are incorporated in the monthly NAV updates.

Please note that this will be the final weekly NAV estimate for the 2021 calendar year. The next weekly NAV estimate will be released on Wednesday 12 January 2022.
