# Ark Mines Limited (ASX: AHK) – Anticipated Reinstatement to Quotation

## Description

It is anticipated that the securities of Ark Mines Limited ('AHK') will be reinstated to quotation at 10:00 am (+/-15 seconds) AEDT on Friday, 24 December 2021, following its re-compliance with Chapters 1 and 2 of the ASX Listing Rules.

AHK raised \$4.7 million pursuant to the offer under its prospectus dated 27 September 2021 as varied by supplementary prospectuses dated 11 November 2021 and 9 December 2021 by the issue of 23,513,500 fully paid ordinary shares at an issue price of \$0.20 per share.
