Placement Cleansing Notice under section 708A(5)(e) of the Corporations Act

Completion of recent capital raisings

SenSen Networks Limited today announces the completion of its recent capital raising.

On 5 November, SenSen announced the completion of an institutional placement (**November Placement**) to raise \$4.2 million and the intention to undertake a Share Purchase Plan (**SPP**). The final fully paid ordinary shares in the November Placement were issued on 21 December 2021 following the approval of Shareholders at the annual general meeting on 17 December 2021. The SPP successfully raised \$2.8 million.

New placement

Consistent with its objective of raising \$10.0 million, as announced at the time of the November Placement, SenSen has today raised an additional \$3.0 million by way of a placement to a high-net-worth investor at 12.0 cents per share, the same price as the November Placement and SPP (**December Placement**).

SenSen confirms that with its target raising of \$10.0 million now achieved, this concludes its current capital raising program. SenSen is now well funded to pursue further growth opportunities in CY2022.
