## ANTAM RECORDED GOLD SALES VOLUME GROWTH IN 2021

Jakarta, January 13, 2022 - PT Aneka Tambang Tbk (ANTAM; IDX: ANTM; ASX: ATM), a member of Mining Industry Indonesia (MIND ID) - the State-Owned Enterprise Holding of the Mining Industry, is pleased to announce that the Company remains recorded positive growth on its gold segment performance within 2021 (unaudited) in line with the positive appreciation on public awareness of gold investment.

In 2021, the unaudited ANTAM's gold production volume of 1.69 tons grew 1% compared to the gold production volume in 2020 of 1.67 tons. The unaudited gold sales volume in 2021 was recorded at 29.38 tons, growing 33% compared to the sales volume in 2020 of 22.10 tons. In the 2021 period, ANTAM also marked the all-time high of the domestic gold sales volume performance with a sales volume of 28.28 tons (unaudited), which rose to 44% from the 2020's domestic gold sales volume of 19.70 tons.

"Along with the growth of public awareness in gold investment, ANTAM focuses on strengthening its precious metal customer base in the domestic market. Throughout 2021, the Company recorded sales volume growth of 33% (unaudited) compared to 2020, reflecting the public's trust in ANTAM's precious metal products in line with Company's commitment to prioritizing security and customer trust through ensuring each transaction is carried out following the goods delivery procedures and official prices determined by the Company."
