### Appendix 4C Quarterly Cash Flow and Activities Report for the Quarter Ending 31 December 2021

iQ3Corp Ltd (“iQ3” or “Company”) (ASX:IQ3), releases its Quarterly Activity Report and associated Appendix 4C (Quarterly Cashflow Report) to the market.

#### Business Activities for the Quarter

During the second quarter, iQ3 continued to deliver on current projects and development of strategic new projects.

The Company has delivered a solid performance during the quarter seizing the opportunities presented by the challenging market conditions which continue as a result of COVID-19.

The key highlights are:

- Cash balance stands at \$275K at the end of the current quarter (Q2 FY22). This is an increase of \$215K when compared to last quarter (Q1 FY22: \$60K).
- An improvement of 27% in net operating cash outflows for Q2 FY22, when compared to the first half of FY21 (net operating outflows H1 FY22: \$1.58m, H1 FY21: \$2.15m). This significant improvement was achieved through the successful implementation of various cost saving initiatives in response to the challenging market conditions which continues to arise as a result of COVID-19.

#### Payments to Related Parties and their Associates (Refer section 6 of Appendix 4C)

During the quarter, the Company paid \$688K in relation to overhead reimbursement costs, consulting fees and directors’ remuneration to its related parties and their associates.
