Answer: The company has announced plans to continue its exploration activities in the next quarter.

Answer: As noted in the financial statements for the half year ended 30 June 2021, the "the Directors expect that additional funds will be required for the Company to operate and conduct exploration activities over the next 12 months. The Company is preparing a capital raising strategy including raising funds through share placements, capital raisings from existing shareholders and from short term loans. The Company has in the past been able to obtain short term loans from professional investors as an interim measure while capital raisings are being finalised. Based on their previous experience and success in raising capital and loan funds, the current market appetite for the commodities for which the Company is exploring and the recent results obtained from the new exploration program, the Directors are confident, these additional funds can be obtained"
