Answer: As set out in the quarterly activities report, the Company is currently undertaking a 50,000m diamond drill campaign (Stage 2 Campaign), which is expected to conclude in the current quarter. The Company expects its net cash outflows to significantly reduce as a result of the completion of the Stage 2 Campaign.

Answer: No, the Company is not in current discussions regarding a capital raising. However, as with all pre-revenue explorers, the Company regularly assesses its budgeted expenditure and the capital markets with a view to raising capital at a time most beneficial to long term shareholder value
