## Shares issued under Share Issue Notice under section 708A(5)(e) of the Corporations Act 2001

This notice is given by Core Lithium Ltd (ABN 80 146 287 809) (the **Company**) under section 708A(5)(e) of the Corporations Act 2001 (**Corporations Act**).

The Company today issued 934,000 fully paid ordinary shares (**Shares**) at an issue price of A\$0.45 per Share to investors that have exercised unquoted options and 500,000 Shares for nil consideration to employees that have exercised performance rights.

The Company advises that:

- (a) the Shares were issued without disclosure to investors under Part 6D.2 of the Act;
