BLAIR ATHOL

Three shipments were sold from Blair Athol (**BA**) during January 2022 which included the shipment from December which was delayed due to poor weather conditions impacting port operations.

BA is fully sold until mid-May 2022 and remains on track for coal sales in the 2022 financial year of approximately 2.3 million tonnes.

SOUTH AFRICA

Total coal sales for the South African operations improved significantly compared to the prior month, increasing by 189kt or 53% and total coal sales were back to year to date run rate levels.

Year to date, contracted domestic offtake quantities have been delivered to Eskom on a combined basis.

¹ The data represents equity tonnes, being the attributable tonnes to TerraCom's equity ownership.

² The data represents total tonnes and assumes 100% ownership of the South African operations, noting TerraCom's interest in the operating mines is 49%.
