Jakarta, February 9, 2022 - PT Aneka Tambang Tbk (ANTAM; IDX: ANTM; ASX: ATM) member of Mining Industry Indonesia (MIND ID) – the State-Owned Enterprise Holding of the Mining Industry, is pleased to announce that the Company has been part of several Index in the Indonesia Stock Exchange (IDX), such as LQ45 Index, IDX30 Index, IDX80 Index, Kompas100 Index, MNC36 Index, IDXBUMN20 Index, Investor33 Index, Jakarta Islamic Index, Jakarta Islamic Index 70 Index, Indonesia Sharia Stock Index, IDX MES-BUMN 17 Index, Bisnis-27 Index, ESG Sector Leaders IDX KEHATI Index and ESG Quality 45 IDX KEHATI, Growth30 Index, IDX High Dividend 20 Index, IDX Small-Mid Cap (SMC) Composite Index and IDX SMC Liquid Index which are the group of stocks with the highest liquidity in IDX.

In addition, ANTAM is also part of the IDX High Dividend 20 Index, which is an Index that measures the stock price performance of 20 stocks that have distributed cash dividends every year over the past 3 (three) years and have high dividend yields. In accordance to Share Prospectus, ANTAM's has a policy to pay cash dividends to all shareholders at least once a year. By taking into account the Company's financial position or level of soundness and without ignoring the rights of the Company's General Meeting of Shareholders, the dividend policy is a minimum of 30% from the net profit after tax except as determined otherwise by the General Meeting of Shareholders.

ANTAM shares are actively traded on the Indonesia Stock Exchange every day, at the end of January 2022 the closing price of ANTAM's shares recorded Rp1,770 per share. The positive performance of ANTAM's shares was also reflected in the average daily trading volume of ANTAM's shares for January 2022 period reached 147.30 million shares with the average daily transaction value for January 2022 period recorded Rp282.33 billion. At the end of January 2022, ANTAM market capitalization amounted Rp42.53 trillion with the ANTAM's total shareholders reached 226,607 investors.
