Re: AGL- CitiFirst Self-Funding Instalment Dividend Announcement

Citigroup Global Markets Australia Pty Limited as Issuer of the AGL CitiFirst Self-Funding Instalments (ASX code AGLSOA, AGLSOP & AGLSOQ), declared the record date for entitlements to AUD 0.16, unfranked dividend for the AGL CitiFirst Self-Funding Instalment is 24 February 2022, coinciding with the record date for AGL ordinary shares.
