

ASX RELEASE**24 FEBRUARY 2022****OVER THE WIRE'S SHAREHOLDERS VOTE IN FAVOUR OF SCHEME**

Over the Wire Holdings Limited (ASX:OTW) is pleased to announce that Over the Wire's shareholders approved the proposed acquisition of Over the Wire by Aussie Broadband Limited (ASX: ABB) by way of scheme of arrangement.

Voting results of the scheme meeting

For the purposes of ASX Listing Rule 3.13.2 and section 251AA(2) of the *Corporations Act 2001* (Cth), Over the Wire advises that the resolution to approve the Scheme as set out in the notice of scheme meeting attached to Over the Wire's scheme booklet dated 21 January 2021 was passed by the requisite majorities of Over the Wire shareholders.

The Scheme Resolution results were:

- 99.03% of Over the Wire's shareholders present and voting at the scheme meeting (via Over the Wire's online meeting platform or by proxy, attorney or corporate representative) voted in favour of the Scheme Resolution; and
- 99.99% of the total number of votes cast on the Scheme Resolution at the scheme meeting (via Over the Wire's online meeting platform or by proxy, attorney or corporate representative) voted in favour of the Scheme Resolution.

Full details of the poll and proxy results for the Scheme Resolution are set out in the attached voting summary.

Next steps

OTW will seek orders from the Federal Court of Australia for the approval of the Scheme at the second Court hearing, scheduled for 10.15am AEDT on Thursday, 3 March 2022.

If the Court approves the Scheme, OTW proposes to lodge the Court orders with the Australian Securities and Investments Commission on Friday, 4 March 2022, at which time the Scheme will become effective.
