DIRECTORS' REPORT TO SHAREHOLDERS

The Directors of VGI Partners Global Investments Limited (the Company or VG1) present their report together with the financial statements of VG1 for the half-year ended 31 December 2021.

VG1 is a company limited by shares and is incorporated in Australia and quoted on the Australian Stock Exchange (ASX) (ticker code: VG1).

Principal activity

The principal activity of the Company is to provide shareholders with access to a concentrated portfolio, predominantly comprised of long investments and short positions in global listed securities, and the investment expertise of VGI Partners Limited, the Investment Manager (**the Manager** or **VGI**). The Manager employs the same investment strategy for the Company as it employs in the management of the VGI Partners Master Fund, VGI Partners Offshore Fund and several Individually Managed Accounts.

There have been no significant changes in the nature of this activity during the period and no change is anticipated in the future.

Review of operations

Investment operations during the half-year resulted in an operating loss before tax of \$113,614,961 (2020: operating profit before tax of \$130,524,999) and an operating loss after tax of \$78,910,919 (2020: operating profit after tax of \$91,836,433).

The investment portfolio returned -10.9% (2020: +13.7%) net of fees for the six months to 31 December 2021 and -2.5% (2020: +8.4%) for the 2021 calendar year.

As at 31 December 2021, the investment portfolio was 90% net long invested and held 15% in short positions. This means that for every \$100,000 invested with VG1 during the year, shareholders owned long \$90,000 of equities and had sold short \$15,000 of equities. This represents a net equity exposure of \$75,000.

The Post-Tax NTA per share as at 31 December 2021 was \$2.34¹ (30 June 2021: \$2.69) representing a decrease of 13%. The Post-Tax NTA per share of \$2.34¹ is after the 5.5 cents per share fully franked final dividend paid to shareholders on 29 September 2021.

As announced in November 2021, the Manager has engaged external advisers to assist in reviewing other options to address the discount to NTA. Pending the outcome of this review by the Manager, the Board has determined it is prudent to pause the VG1 buy-back.

Costs paid by the Manager

The Manager continues to show strong alignment and support to the Company and its shareholders by paying the majority of the Company's operating costs. In the six months ended 31 December 2021, the Manager paid for over \$676,000 of operating expenses (2020: \$314,000) which include ASX and ASIC fees, audit costs, legal and tax advice costs, external advisor costs and any fees charged by the Company's Fund Administrator.

¹ 'Post-Tax NTA' is calculated after tax on realised gains/losses, deferred tax assets and deferred tax liabilities, but before allowing for deferred tax liabilities / deferred tax assets on unrealised gains / losses.

On-market share buy-back program

As part of the on-market buy-back of shares announced on 18 August 2020, the Company bought back 4,401,098 shares at a cost of \$10,632,389 (excluding brokerage) in the six months to 31 December 2021. On 17 August 2021, the Company announced its intention to extend the on-market share buy-back for a further period of up to 12 months.

Financial position

The net assets of the Company as at 31 December 2021 were \$873,448,997 (30 June 2021: \$983,926,676).

The Company continued to maintain a profits reserve in the Statement of Financial Position for the purpose of retaining profits and paying dividends in the future.

Subsequent events

The Directors have declared a fully franked dividend of \$17,120,438 (4.5 cents per share), which will be paid on 19 April 2022.

On 31 January 2022, the Manager of the Company announced that the Manager is in merger discussions with Regal Funds Management Pty Limited (**Regal**). At the date of this report, VGI confirms that confirmatory due diligence and the negotiation of the terms of a binding merger implementation agreement, which will be subject to final board approvals of each of VGI and Regal, remains ongoing. VGI will continue to keep shareholders and the market informed of material developments in accordance with its continuous disclosure obligations.

The Company is not aware of any other matter or circumstance since the end of the financial period not otherwise dealt with in this report, that has, or may, significantly affect the operations of the Company, the results of those operations or the state of affairs of the Company in subsequent financial periods.

Rounding of amounts to nearest dollar

The Company is an entity of the kind referred to in ASIC Corporations (Rounding in Financials/Directors' Reports) Instrument 2016/191, and in accordance with that Corporations Instrument, amounts in the financial statements are rounded off to the nearest dollar, unless otherwise indicated.

NOTES TO THE FINANCIAL STATEMENTS

1. Summary of significant accounting policies

This note provides a list of the significant accounting policies adopted in the preparation of the half-year financial statements to the extent they have not already been disclosed in the other notes below. These policies have been consistently applied to all the periods presented and consistent with those adopted and is disclosed in the Annual Financial Report for the year ended 30 June 2021, unless otherwise stated.

(a) Basis of preparation

The Half-Year Financial Report for the period ended 31 December 2021 has been prepared in accordance with the *Corporations Act 2001* and *AASB 134 Interim Financial Reporting*, as appropriate for for-profit oriented entities. Compliance with AASB 134 ensures compliance with International Financial Reporting Standard IAS 34 *Interim Financial Reporting*.

The Half-Year Financial Report does not include all the notes of the type normally included in annual financial statements. Accordingly, these financial statements should be read in conjunction with the most recent Annual Financial Report as at 30 June 2021 and any public announcements made by the Company during the interim reporting period.

In accordance with ASIC Corporations (rounding in Directors' Reports) Instrument 2016/191, the amounts in the Directors' Report and in the financial statements have been rounded to the nearest dollar unless otherwise specified.

(b) Functional and presentation currency

Items included in the financial statements are measured using the currency of the primary economic environment in which the entity operates (**the functional currency**). The financial statements are presented in Australian dollars (\$), which is the Company's functional and presentation currency.

(c) Application of new and revised accounting standards and interpretations

There are no new and revised accounting requirements significantly affecting the half-year ended 31 December 2021 financial statements.

(d) Significant accounting policies

The half-year financial statements have been prepared using all other accounting policies used in the recent annual financial statements for the year ended 30 June 2021.

(e) Going concern

The Half-Year Financial Report has been prepared on a going concern basis.

2. Segment information

The Company has only one reportable segment. The Company is engaged solely in investment activities, deriving revenue from dividend income, interest income and from the sale of its investments.

- Level 1 fair value measurements are those derived from quoted prices (unadjusted) in active markets for identical assets or liabilities;
- Level 2 fair value measurements are those derived from inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly (i.e., as prices) or indirectly (i.e., derived from prices); and
- Level 3 fair value measurements are those derived from valuation techniques that include inputs for the asset or liability that are not based on observable market data (unobservable inputs).

Included within Level 1 of the hierarchy are listed investments. The fair values of these financial assets and liabilities have been based on the closing quoted last prices at the end of the reporting period, excluding transactions costs.
