Net Asset Value as at 25 February 2022

The weekly estimated unaudited net asset value (**NAV**) before withholding tax as at 25 February 2022 was \$0.71* per unit.

If estimated tax on unrealised portfolio gains or losses were recognised, the weekly estimated unaudited post tax net asset value as at 25 February 2022 would be \$0.62* per unit.

Calculation of weekly NAV

This weekly unaudited NAV estimate has been calculated by reference to the Fund's most recent estimated unaudited monthly NAV at 31 January 2022 now reflecting the audited property valuation in the 31 December 2021 Full-Year Financial Report released on 28 February 2022 (being \$0.74 per unit on a pre-tax basis and \$0.65 per unit on a post-tax basis which applied an AUD:USD foreign exchange rate of 0.7067), adjusting for changes in the AUD:USD foreign exchange rate and units issued on 23 February 2022 under the Fund's distribution reinvestment plan.

The applicable AUD:USD foreign exchange rate applied in calculating the estimated unaudited NAV as at 25 February was 0.7226.

These weekly estimates do not take into account all intra-monthly accruals, which are incorporated in the monthly NAV updates.
