The dividend has been declared in USD. The exchange rate for the dividend to holders of CDIs trading on the ASX who wish to receive their dividend in Australian dollars will be 0.7325 US dollars per 1 Australian dollar. The dividend to be paid in Australian currency to CDI holders will be approximately 0.0210 per CDI in Australian dollars after rounding due to conversion.
