



Tin Projects – Exploration Update

DORADILLA PROJECT

- Diamond drilling rig is mobilising to the 3KEL Target – Drilling to recommence at Doradilla.
- RC drilling rig has been secured to mobilise later in the month to advance the 3KEL Target, testing tin and zinc mineralisation over a broad 2.8km strike length.

TALLEBUNG PROJECT

- RC Drilling of 10 holes has been completed for a total of 1,217m at the historic Tallebung Tin Mine targeting a shallow, bulk tonnage tin deposit. Previous results include:

TBRC006: 87m @ 0.18% tin from 60m, including;
1m @ 5.83% tin & 0.36% tungsten from 60m and;
3m @ 0.92% tin from 69m

TBRC009: 44m @ 0.21% tin from 69m, including;
5m @ 1.33% tin from 69m

- All 10 holes completed successfully intercepted the Tin Lode system at Tallebung – Assays are pending.

The Board of Sky Metals Limited ('SKY' or 'The Company') is pleased to provide an update on exploration activities at the Tallebung Tin Target at the Tallebung Project and the 3KEL Target at the Doradilla Project, both in NSW.

DORADILLA PROJECT: TIN- POLYMETALLIC (EL 6258, SKY 100%)

3KEL TARGET – DIAMOND DRILLING




Figure 1: 3KEL Target - Cross section of 3KRC012 and the proposed hole to drill for depth extensions to the multiple, strong tin intercepts.

A diamond drilling rig is scheduled to arrive onsite at the 3KEL Target this week. An RC drilling rig has also been secured to join the diamond drilling rig at 3KEL by the end of the month. The first hole to be completed on this next round of diamond drilling at 3KEL is aimed to target depth extensions to the tin mineralisation at 3KEL under **3KRC012**. Figure 1 shows the planned hole on section. **3KRC012** intercepted multiple intervals of strong tin mineralisation, results included:

3KRC012: 37m @ 0.31% tin from 91m,
15m @ 0.16% tin from 69m,
5m @ 0.23% tin from 44m.

SKY Exploration Manager Oliver Davies commented *"It is an exciting time for SKY, we are mobilising to recommence drilling at the exceptional 3KEL Target, as localised flooding has now abated, and SKY eagerly anticipates the assays results from the RC drilling at the Tallebung Tin Project to be received over the next few weeks. SKY is quickly advancing our tin exploration portfolio as the tin price continues past a record AUD60,000/t."*

The second hole planned in this program will be drilled as a wide diameter hole to provide a sample for metallurgical testwork. This hole has been planned to intercept the high-grade tin mineralisation in **3KRC007**, results included:

**3KRC007: 42m @ 0.41% tin from 37m including,
7m @ 1.31% tin & 0.22% copper from 63m**

The last of the planned diamond holes for this program has been designed to test under the zinc mineralisation discovered 500m along strike from **3KRC012** in **3KDD013**. The RC drilling rig is also planned to continue the drilling program, starting on the north-eastern end of the 3KEL Target before moving to the south-west along a 2.8km strike.

This RC program will explore extensions to the zinc mineralisation in **3KDD013** while also testing underneath the rock chips results from the large and undrilled gossanous area 200m further to the northeast. Rock chips taken from this undrilled gossanous area assays up to 0.7% tin and may represent a +700m extension to the north-east of the 3KEL Target.

A camp is currently being set up near the 3KEL Target to allow for better access for SKY staff and contractors for the ongoing drilling programs planned over at least the next 3 months.




Figure 2: 3KEL Target – Cross section of 3KRCD007 and 3KDD014 with the planned metallurgical hole drilling down the tin mineralisation to provide sample for metallurgical testwork.




Figure 3: 3KEL Target - Long section of showing the locations of the planned diamond and RC drillholes for the imminent drilling programs.

TALLEBUNG PROJECT: TIN- TUNGSTEN (EL 6699, SKY 100%)

TALLEBUNG TARGET – RC DRILLING

Nine of the eleven planned RC holes and one redrilled hole, ten holes altogether, for a total of 1,217m have been completed at the historic Tallebung Tin Mine, designed to test for further up dip, shallow potential bulk tonnage tin mineralisation.

All ten holes drilled intercepted broad zones of quartz veining and alteration prospective for tin. Visual logging of these holes shows that the tin lode system at Tallebung remains open up dip, providing a strong indication of additional tin mineralisation close to surface at Tallebung. All samples have been submitted to the lab and assays are pending.

Further RC drilling is being planned for later in the month to complete this program and expand the shallow Tallebung Tin Target. Tin mineralisation at Tallebung has a strike of over 1.2km and remains open along strike. This recent drilling by SKY demonstrates great potential to further increase the size of the Tallebung Target in shallow, up dip extensions. SKY anticipates the return of these assay results over the next few weeks.

Tin mineralisation at Tallebung is hosted as coarse cassiterite (tin-oxide) indicating favourable concentration by traditional gravity methods. A sample of the Tallebung tin mineralisation has been sent to TOMRA Ore Sorting Solutions in Sydney and has been sorted on a 25:75 product to waste ratio – Assays are also pending for these testwork samples to provide an indication of the effectiveness of ore sorting for the Tallebung tin mineralisation.




Figure 4: Tallebung Target – Cross section showing TBRC006 and other holes drilled on section within a 50m wide window. TBRC006 is open up dip for over 100m to surface and has been tested by TBRC014 – Assays are pending.




Figure 5: Tallebung Target - Plan view of the geology at Tallebung overlain by drillhole traces coloured by downhole tin assays (NB 5000ppm = 0.5% tin). RC holes in this latest program are shown by the red traces with yellow labels.

GOLD PROJECTS

CULLARIN / KANGIARA PROJECTS (EL7954; EL8400 & EL8573, HRR FARM-IN)

Under the HRR farm-in, SKY has now earned an 80% interest in the projects via the expenditure of \$2M (ASX: 9 October 2019). 'McPhillamys-style' gold results from previous drilling at the Cullarin Project include 148.4m @ 0.97 g/t Au (WL31) including 14.6m @ 5.1 g/t Au from 16.2m, & 142.1m @ 0.89 g/t Au (WL28) including 12m @ 4.4 g/t Au from 25.9m. The Cullarin Project contains equivalent host stratigraphy to the McPhillamys deposit with a similar geochemical, geophysical & alteration signature. SKY's maiden drill program was very successful including core hole HUD002 which returned 93m @ 4.2 g/t Au from 56m.

CALEDONIAN / TIRRANA PROJECTS (EL8920, EL9048, EL9120 100% SKY)

Highlight, 'McPhillamys-style' gold results from previous exploration include 36m @ 1.2 g/t Au from 0m to EOH in drillhole LM2 and 81m @ 0.87g/t Au in a costean on EL8920 at the Caledonian Project. The distribution of multiple historic drill intersections indicates a potentially large gold zone with discrete high-grade zones, e.g. 6m @ 8g /t Au recorded from lode at historic Caledonian Mines (GSNSW). A strong, robust soil gold anomaly (600 x 100m @ +0.1ppm) occurs and most drillholes (depth ~25m) terminate in the mineralised zone.

COPPER GOLD PROJECTS

GALWADGERE (EL6320, 100% SKY)

The Galwadgere project is located ~15km south-east of Wellington in central NSW. High grade copper-gold mineralisation has been intersected by previous explorers (e.g. 47m @ 0.90% Cu & 1.58g/t Au) and the mineralisation is open along strike and at depth.

IRON DUKE (EL6064, BALMAIN OPTION; EL9191 100% SKY)

The Iron Duke project is located ~10km south-east of Tottenham in central NSW. High grade copper-gold mineralisation has been intersected by previous explorers (e.g. 13m @ 1.56% Cu & 4.48g/t Au)

TIN PROJECTS

TALLEBUNG PROJECT (EL6699, 100% SKY)

The Tallebung Project is located ~70km north-west of Condobolin in central NSW. The project encompasses the historic Tallebung Tin Mining Field at the northern extent of the Wagga Tin Belt within the central Lachlan Orogen and is considered prospective for lode and porphyry-style tin - tungsten mineralisation.

DORADILLA PROJECT (EL6258, 100% SKY)

The Doradilla Project is located ~ 30km south of Bourke in north-western NSW and represents a large and strategic tin project with excellent potential for associated polymetallic mineralisation (tin, tungsten, copper, bismuth, indium, nickel, cobalt, gold).

NEW ENGLAND PROJECT (EL9200 & 9210, 100% SKY)

SKY has been granted two exploration licences in the New England Orogen covering areas of significant historical tin production - Emmaville & Gilgai. These areas were selected as they were considered to have considerable potential to host hardrock tin resources and limited modern day exploration has been conducted.




Figure 6: SKY Location Map
