Extension of Closing Date for Retail Entitlement Offer

On 21 February 2022, Chimeric Therapeutics Limited (ASX:CHM) (**Chimeric** or **Company**) announced the details of an accelerated non-renounceable entitlement offer (**Entitlement Offer**) to raise approximately \$18.1 million (before the exercise of any new options).

Under the Entitlement Offer, eligible retail shareholders are able to subscribe for 1 new fully paid ordinary share in Chimeric (**New Share**) (and 1 new option for every New Share issued with an exercise price of \$0.255 per new option and exercisable on or before 31 March 2024¹ (**New Option**)) for every 3.15 fully paid ordinary shares in Chimeric held as at 7pm (Sydney time) on Wednesday, 23 February 2022 at the issue price of \$0.17 per New Share.

The Entitlement Offer includes an institutional component (Institutional Entitlement Offer) and a retail component (Retail Entitlement Offer). Chimeric announced the successful completion of the Institutional Entitlement Offer on 23 February 2022.

Extension of Closing Date for Retail Entitlement Offer

Chimeric advises that the Closing Date of the Retail Entitlement Offer has been extended by seven days to 5:00 pm (Sydney time) on Friday, 18 March 2022 (**Extended Closing Date**). The Extended Closing Date is to ensure all eligible retail shareholders have an additional opportunity to participate in the Retail Entitlement Offer.

Revised indicative timetable²

The Extended Closing Date will have a consequential effect on the indicative timetable, including the date of allotment and issue of the New Shares and New Options under the Retail Entitlement Offer and the New Options under the Institutional Entitlement Offer which is now anticipated to occur on 5:00 pm (Sydney time) on Friday, 25 March 2022. The expiry date of the New Options will remain 31 March 2024.

Eligible institutional shareholders must, at the issuance date of the New Options, hold at least the number of New Shares they subscribed for under the Institutional Entitlement Offer.

All dates are indicative only and subject to change. Chimeric reserves the right to withdraw or vary the timetable without notice.
