Over the Wire scheme implementation and appointment of Director

Aussie Broadband Limited (ASX:ABB) is very pleased to acknowledge the announcement by Over the Wire Holdings Limited (ASX:OTW) that the scheme of arrangement with its shareholders was implemented today ([OTW announcement](#)).

The scheme was approved by shareholders on 24 February 2022, and by the Federal Court of Australia on 3 March 2022.

Aussie Broadband now holds all shares in Over the Wire. Former Over the Wire shareholders on the scheme record date (8 March 2022) have been paid according to the respective elections of scaled back cash and scrip.

Board changes

Following the implementation of the scheme and as foreshadowed in the announcement on 2 December 2021, there have been changes to the Aussie Broadband board.

He has one of the most creative technical minds in the industry, and we look forward to his ongoing contribution and leadership to the enlarged group.”
